**1. Introduction**

Title: State management of enterprise equitization in Hanoi.

**2. Summary of contents of the information page**

*Firstly*, the thesis defines that State management of enterprise equitization is an organizational and oriented impact and under the management of State agencies for the equitization of State-owned enterprises through management methods and tools to facilitate the process of equitization effectively, achieve targets of arranging, reforming and restructuring State enterprises and contribute to the sustainable socio-economic development.

*Secondly*, the thesis shows limitations of State management for enterprise equitization in Hanoi in term of building and implementation of equitization programs. Causes of these limitations: i) restructuring and equitization of State-owned enterprises were implemented when the economic context in Vietnam and the world had a lot of difficulties; ii) lack of experiences in the equitization of large-scale enterprises; iii) there is a large numbers of State-owned enterprises in need of equitization; iv) propagation work is not effective; v) mechanisms and policies are not promulgated as the plan; vi) difficulties and problems related to the public finance have not been handled thoroughly by functional agencies; vii) organization of the apparatus which works on equitization of State enterprises is still overlapped.

*Thirdly*, the thesis puts forward 03 solution groups to perfect the State management of enterprise equitization in Hanoi including (1) *Group of solutions on creating necessary prerequisites for the equitization of State enterprises* (including: solutions to ideological work and propagation; solutions to administrative reform; additional solutions, complete criteria for classification; solutions for perfecting plans; solutions to the organization of State management human resource and apparatus; solutions to supervision and inspection; solutions for organizing seminars and compiling documents. (2) *Group of solutions on the financial mechanism and policies* (including: solutions regarding the mechanism and policies; defining, separating and processing remained financial items of the enterprise after equitization; solutions of public finance; equitization of State enterprises is associated with development of stock market and (3) *Group of solutions on raising the effectiveness of the State management after equitization* (including: solutions of training, arranging the key staff; solutions to labor redundancy; solutions to renew management practices; solutions to consolidate and enhance the role of the Party and mass organizations in enterprises after equitization; solutions of information and report modes).

*Fourthly*, the thesis also recommends some solutions to the Party, the State, the Government and ministries, sectors to contribute to promoting the restructuring and reorganization of State enterprises in the national scope, including: i) further restructure the State-owned enterprises with the focus on State cooperations and general corporations; ii) reforming and applying the modern management frame; iii) perfecting the management mechanism of owners, and proposing to the government to establish ministerial-level specialized agencies to perform the function as the owner of State enterprises and joint-stock companies with State capital./.
