SUMMARY OF NEW CONTRIBUTIONS OF THE DISSERTATION

2. Content

Firstly, the dissertation expresses the concept of State management of agricultural economics restructuring as “is action with nature of power of State authorities in the management of the agricultural sector, organizing the production and altering structures and relationships interact in the target-oriented and agricultural economic development.

Secondly, the dissertation identifies content for State management of agricultural economics restructuring includes: i) Develop and implement the strategy, planning, development plans and organization of agricultural economics restructuring; ii) Developing and enforcing legal system for agricultural economics restructuring; iii) Developing and implementing policies for agricultural economics restructuring; iv) Strengthening the organizational structure of the State management for agricultural economics restructuring; v) Inspection and supervision of the State for agricultural economics restructuring.

Thirdly, the dissertation proposes State management under associated symbiotic model of “5 sectors” (including State, Agriculture, Enterprise, Science and Bank) in agricultural production, on this basis to clarify roles, responsibilities and rights of the "sectors" for sustainable agricultural development.

Fourthly, the dissertation points out the fundamental limitations of State management for of agricultural economics restructuring in Vietnam, including i) the coordination between different levels and sectors related to agricultural production is not timely and closely, State management system on Agriculture and Rural Development from provincial to commune level is still limited; ii) the allocation of investment funds does not meet the requirements of development and is not commensurate with the contribution of the agricultural sector; the research, science-technology transfer and training of human resources for agricultural development are limited; iii) the capacity of civil servants and employees in many agencies, State management units is weak, lack of experience on advising management; a part of leaders is lack of vision for organizational; working methods lack of professionalism,

lack of leadership skills and afraid to apply new technologies on management; iv) formulation of legal documents, programs, schemes and standards, national technical regulations on state management for Agriculture and Rural Development has been slow, low quality and cannot meet the request of agricultural development; v) the role of "conductor" of the State is not to promote efficiency; the development of mechanisms and policies on the practical implementation is limited led to the management, the organization connecting "sectors" in agricultural production and consumption of agricultural products is still insufficient.

Fifthly, the dissertation proposes the remedies, including: i) Clearly defining the functions, duties and responsibilities of state management of agriculture and rural development among ministries; defining the responsibilities for state management to develop agricultural production for Chairman of People's Committee of Province and Cities under central authority; increasing the resources to meet the requirements of local state management (especially at commune level); ii) Prioritizing the allocation of capital for medium-term 2016-2020 doubled compared with the total investment of the period 2011- 2015 according to the Central Resolution No. 7, Session X on "Agriculture, farmers and rural areas"; strengthening training of human resources for the implementation of agricultural production of high-tech agriculture; iii) Strengthening advisory skills, leadership and management skill; building criteria; periodically evaluating the implementation of the task of civil servants and leaders of agencies, state management units; iv) evaluating the results and efficiency of legislation formulation; strengthening training, improving capacity for civil servants and leaders of agencies, state management units with the task of building legislation; v) Strengthening the inspection, monitoring and evaluation of agricultural production activities; reviewing and assessing the effectiveness of policies issued; defining mechanisms and responsibilities, the interests between "sectors" in the development of agricultural production.
