## 2. Content page summary information

Firstly, state management for foreigner residence is defined as the adjustment and correction conducted by state power belonging to governmental bodies or state-authorized agencies (especially including Public Security forces), which aims to preserve and protect national security and sovereignty as well as to create favorable conditions for foreigners to carry out their rights and duties on Vietnam and international residence law.

Secondly, state management for foreigner residence framework including: i) the operation of management activities; ii) the promulgation and supervision of law documents of foreigners' residence; iii) the inspection, examination and punishment of any law infringement; iv) international cooperation.

Thirdly, some of other countries' experience on state management of foreigners' residence which should be learnt from are: i) the construction and completion of the management regulation; ii) the management allocation and decentralized administration; iii) the operation of working and managing processes; iv) prevention and deterrence of law infringement.

Fourthly, there are some limitations in the State management for foreigners' residence in Southern Central provinces and cities: the late and unreasonable promulgation of law document; the limited propaganda campaigns, the malfunction and weak synchronization between inspecting and punishing law infringement. Causes of these limitations are: i) Due to the relevant authorities not to promote the role and responsibilities adequately; ii) qualifications, staff capacity; iii) complex practical situation; iv) vehicles, equipment, facilities limited; v) legislation has some limitations in certain times.

Fifthly, from the viewpoint of completing state management on foreigners' residence (ensure the national independence and sovereignty, national security and social order; guarantee the lawful rights and duties of foreigners; fulfill the demand of international integration; maintain the transparency and publicity of the state modernization), thesis proposes solutions for completing state management on foreigners' residence include: i) perfecting the executive bodies and operational staff; ii) editing and promulgating law documents of state management on foreigners' residence; iii) improving the effectiveness of inspecting and settling law infringements; iv) boosting up international cooperation; v) investing in the modernization of technical infrastructure, managing equipment and tools.
